Rear Garden:

T1: Mature Magnolia: Approximately 7.00m: Reduce crown by approximately 20% (1.20m-1.40m). Thin crown density throughout by 20%. Remove dead wood and weak epicormic growth throughout crown. General maintenance.

T2: Mature Magnolia: Approximately 6.00m: Reduce crown by approximately 15% (1.00m) ensuring overlong extraneous branches are pruned back into main crown structure. Remove dead wood. Thin crown density by 10%. General maintenance.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
