T1 - sweet chestnut (10m) - reduce crown to previous pruning points, approximately 1.5m reduction and reduce height of ivy by approximately 3m. Remove all Ivy.
T2 - 3 lime trees (5m) - reduce crown to previous pruning points, approximately 1m reduction.
T3 - twin stemmed holly tree (5m) - reduce height by up to 1.5m and trim sides with hedge cutters.
T4 - crab apple tree (5m) - reduce right side of crown by approximately 1.5m to balance tree.
(T5 - cherry tree (4m) - remove dead branch
You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
