Proposal:

Replacement of existing conservatory uPVC windows and doors, roof sheets and rafters to new aluminium windows and doors, roof sheets and rafters.

Drawing Nos: Block Plan, Location Map; Existing Elevations; Proposed Elevations; Aluminium Window Cross Section (Manufacturers Specification - 1 page); Aluminium Double Door Cross Section (Manufacturers Specification - 6 pages); Design and Access Statement received on 29th April 2022.

The Council has considered your application and decided to grant permission subject to the following condition(s):

Condition(s) and Reason(s):

1 The development hereby permitted must be begun not later than the end of three years from the date of this permission.

Reason: In order to comply with the provisions of Section 91 of the Town and

Country Planning Act 1990 (as amended).

All new external work shall be carried out in materials that resemble, as closely as possible, in colour and texture those of the existing building, unless otherwise specified in the approved application.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policies D1 and D2 of the London Borough of Camden Local Plan 2017.

The development hereby permitted shall be carried out in accordance with the following approved plans: Block Plan, Location Map; Existing Elevations; Proposed Elevations; Aluminium Window Cross Section (Manufacturers Specification - 1 page); Aluminium Double Door Cross Section (Manufacturers Specification - 6 pages); Design and Access Statement received on 29th April 2022.

Reason: For the avoidance of doubt and in the interest of proper planning.

Informative(s):

1 Reasons for granting permission:

The application site is an eight-storey mansion block constructed in the 1920s and located in the Bloomsbury Conservation Area.

The proposed works seek to replace an existing conservatory uPVC windows and doors, roof sheets and rafters with new aluminium windows and doors, roof sheets and rafters on the southeast section of the roof for Flat 56 on the eighth floor. The existing conservatory is deemed unfit for purpose. The new conservatory would have the same footprint and dimensions as the existing and is therefore considered acceptable in terms of size and massing.

The conservatory would have aluminium framed doors and windows which would reflect the fenestration of the building below and are considered appropriate on the building.

The roof would be finished with white aluminium panels and new rafters which would be sympathetic to the host building.

The proposal would not be visible from the street or public realm. It would not affect the appearance of the roofscape or the character or appearance of the Conservation Area.

No new opportunities for overlooking would arise from the proposal. The proposal is not considered to cause any adverse impacts on the amenity of adjoining residential occupiers.

The site's planning and appeals history has been taken into account when coming to this decision. No objections have been received following statutory

consultation.

Special attention has been paid to the desirability of preserving or enhancing the character or appearance of the Bloomsbury conservation area, under s.72 of the Planning (Listed Buildings and Conservation Areas) Act 1990 as amended by the Enterprise and Regulatory Reform Act 2013.

As such, the proposed development is in general accordance with policies A1, CC1, D1 and D2 of the Camden Local Plan 2017. The proposed development also accords with the London Plan 2021 and the National Planning Policy Framework 2021.

Noise from demolition and construction works is subject to control under the Control of Pollution Act 1974. You must secure the approval of the Council's Noise and Licensing Enforcement Team prior to undertaking such activities outside these hours.
