Advised to consult with Primrose Hill CAAC prior to finalising paint colour, and agreed with specialist architect on this project, Paul Latham, that a paint analysis would be advisable to ascertain original colour - if funding would permit.

We have since received approval for the proposed colour from the Primrose Hill CAAC by email, following a committee meeting - copied in below:

Dear Julia.

Restoration of Railings & Stonework - Primrose Hill Primary School

The PHCAAC were delighted to hear that the School has been granted the funds for the restoration of the railings and stonework. We are happy with the colour proposed for the railings and gates.

We noted the colour analysis which has been made. We also noted that the Victorian Society records red and chocolate brown as colours used for railings in the period.

We further noted that the school building has three types of brick – blue-black engineering brick, London stocks, and a red brick, as well as the limestone details and plinths. The configuration of the brick types means that the railings are largely (though not only) seen against the engineering brick podium to the building, while they are set within the red-brick dressings to the piers which form a frame to the railings. The proposed colour would enhance the perception of the railings as set within the red-brick detailing to the building.

We suggest that a display board showing the colour analysis and background to the restoration might be put up to explain the work to the community during the work.
