Species: 1 x Acer (Sycamore) & 1 x Fraxinus (Ash) Position: Central near rear garden Reason: Outgrowing location/shade/dieback on Ash TPO: TBC Drop Zone: Yes Reduce and shape crown(s) by approximately 30%, removing lateral growth by approximately 3-4m, cutting back to nearest suitable growing point, to leave a flowing branch line without stumps and the main canopy framework to B.S.3998:13.4.1. (Please Note: The % relates just to the tree canopy and not the entire tree height). Remove all major dead and diseased wood and generally clean up canopy. Remove all main dead wood, snags, pegs and broken branches exceeding 10mm in diameter or 100mm in length and leave canopy clean and tidy, to B.S.3998. Species: 1 x Pyracantha (Firethorn) Position: Neighbours trespass, near left Reason: Outgrowing location/shade/trespass TPO: N/A Drop Zone: Yes Reduce and shape crown(s) by approximately 30%, removing lateral growth by approximately 3m, cutting back to nearest suitable growing point, to leave a flowing branch line without stumps and the main canopy framework to B.S.3998:13.4.1. Lop back all trespass over boundary line. (Please Note: The % relates just to the tree canopy and not the entire tree height). Remove all major dead and diseased wood and generally clean up canopy. Species: 1 x Populus (Poplar) sapling Position: Upper wild lawn Reason: Shade/self sown TPO N/A Drop zone: Yes Fell above as close to ground level as reasonably practical, by sectional lopping / dismantling and roping down as necessary, to B.S.3998:21.3. Drill the cambium layer every 10cm around diameter and supply and insert into stump/s to prevent regrowth, to B.S.3998:21.2 the following: Ammonium Sulphate Stump Killer. Species: 1 x Prunus (Cherry) Position: Neighbours rear boundary Reason: Deadwood TPO: N/A Drop zone: Yes Remove all main dead wood, snags, pegs and broken branches exceeding 10mm in diameter or 100mm in length and leave canopy clean and tidy, to B.S.3998, inside boundary. Species: 1 x Small Quercus Ilex (Evergreen Oak) Position: Upper right border Reason: Leaf damage TPO: N/A Drop zone: Yes Reduce and shape crown(s) by approximately 25%, removing lateral growth, cutting back to nearest suitable growing point, to leave a flowing branch line without stumps and the main canopy framework to B.S.3998:13.4.1. (Please Note: The % relates just to the tree canopy and not the entire tree height). Remove all major dead and diseased wood and generally clean up canopy. You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
