REAR GARDEN: 2 x Oak (Quercus Robur) - Reduce and shape crown by approx. 2m - 3m, removing lateral growth by approx. 2m, cutting back to nearest suitable growing point, to leave a flowing branch line without stumps and the main canopy framework to B.S.3998:13.4.1. Remove all diseased wood and generally clean up canopy.

1 x Horse Chestnut (Aesculus Hippocastanum) - Reduce and shape crown(s) by approx. 2m - 3m, removing lateral growth by approx. 2m, cutting back to nearest suitable growing point, to leave a flowing branch line without stumps and the main canopy framework to B.S.3998:13.4.1.

2 x Leylandii - Trim back by 1m - 2m.

1 x Bay - Trim back by 1m - 2m.
