## Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

The proposal is for the felling of a single conifer that was planted circa 20 years ago in my back garden and has now grown to approx 10 meters in height. The application is being made on the basis that 7 Briardale is in a conservation area. It is not believed that this is a listed tree.

The tree has developed needle cast affecting its lower part (see photo). At 1.5 meters the circumference is 57 cms which equates to a diameter of 18cms (7.2 inches). The tree is 14.5 meters from the rear (kitchen) wall of 7 Briardale Gardens, 60 cms from the fence between Nos 9 and 7 Briardale Gardens and 5.5 meters from the rear boundary with 38 Pattison Rd NW2 2HJ (LB Barnet). It is considered to be of low amenity value. There are no other trees on my property that are in proximity to this conifer however there is a mature horse chestnut in the rear of 38 Pattison Rd, NW2 2HJ which is immediately to the rear of and overhangs my property and also a semi mature sycamore immediately to the rear of 9 Briardale Gardens. The conifer in question abuts both of these trees and is deprived of light by both of them to its northerly aspect. There is a wooden garden shed in the rear of my property about 1.5 meters from the conifer and also a second world war brick and concrete air-raid shelter in the rear of my property (both are shown on attached photo).

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

Your plan needs to show the precise location of the tree(s) in relation to nearby property/roads/boundaries. It should, therefore:

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
  - mark and name surrounding roads
  - sketch in buildings, including adjoining properties
  - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - marking all trees on the plan, but only numbering those to which you want to carry out work
  - showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
