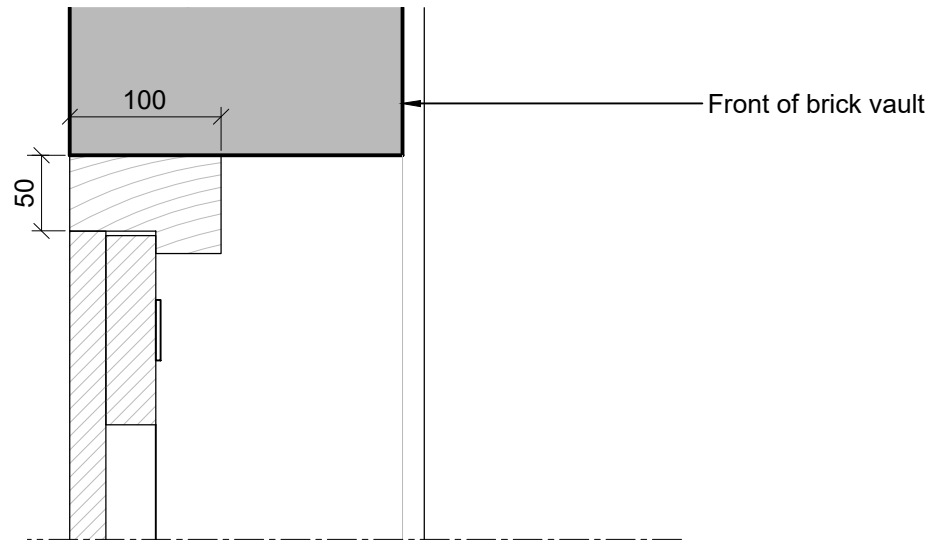


01 Plan D-D

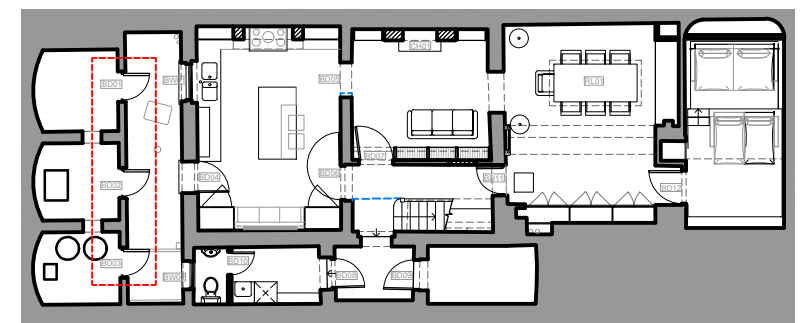


02 Door Head Detail

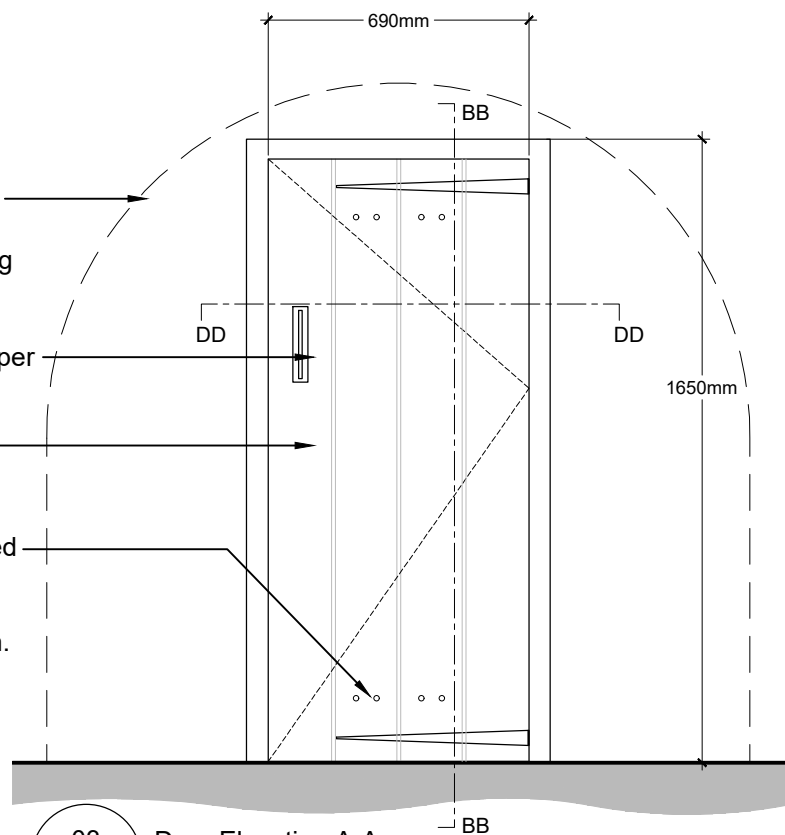
00 Basement Key Plan

Dashed line indicates line of vault behind. TBC following opening up works.

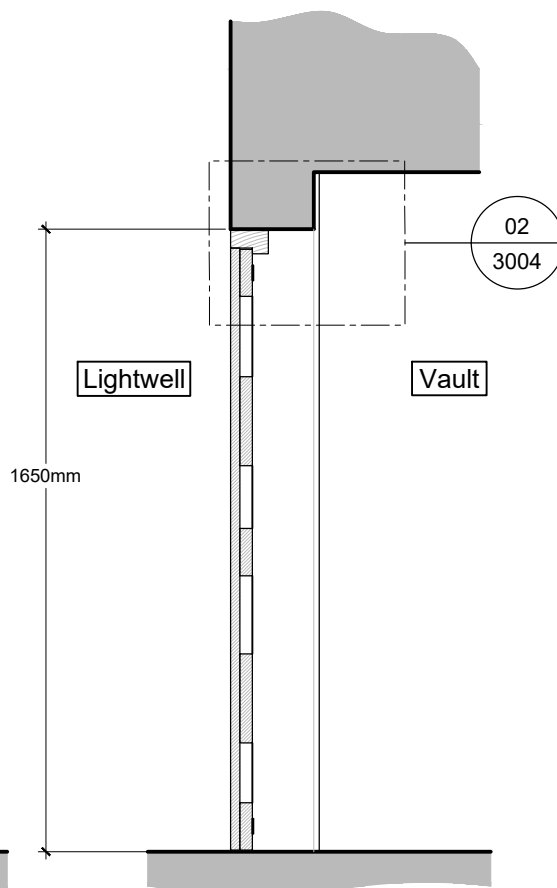

New ledged and braced timber door

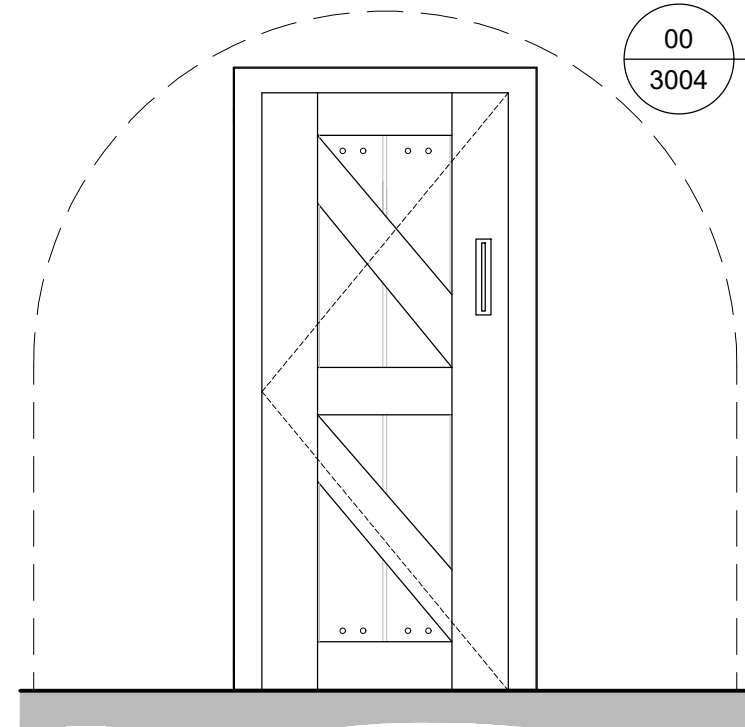

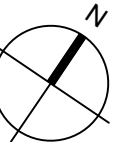
03 Door Elevation A-A
