Unsuitable location for species in very close proximity to boundary and hard landscape, requiring cyclical pruning to prevent direct damage, and inadequate space to allow the trees to reach their mature size.

Supressed, leaning trees with restricted rooting environment.

T1 and T2 - Section fell to ground level and treat stumps to prevent regrowth
