The Council has considered your application and decided to grant permission subject to the following condition(s):

Condition(s) and Reason(s):

1 The development hereby permitted must be begun not later than the end of three years from the date of this permission.

Reason: In order to comply with the provisions of Section 91 of the Town and Country Planning Act 1990 (as amended).

2 The development hereby permitted shall be carried out in accordance with the following approved plans

Site Location Plan, Proposed Elevations and Details 01, Design and Access Statement

Reason: For the avoidance of doubt and in the interest of proper planning.

Informative(s):

1 Reasons for granting permission.

The proposal is for the erection of a steel light fitting at 1st floor level on the front elevation of the building to provide external lighting to help identify the building, which is used as a charity to help vulnerable children.

The fitting would project out of the front elevation by 0.2m and measure 0.8m in height and 0.4m wide. The fitting would be in an appropriate fascia level location, would be of a modest size subordinate to the front elevation and would be finished in bare steel which would be sympathetic to the host building and streetscene.

The proposal has been reviewed by the Council's Public Lighting Team and Transport Team who have deemed the light fitting to be acceptable in highway and amenity terms.

One response was received from the Camden Town CAAC who stated that they support the fitting being modest and of a bespoke design.

The light from the fitting would largely emit downwards to the street with some spillage sideways down the street and would not have a significant impact on windows at upper levels. It is considered that the light would not cause any amenity harm to neighbouring occupiers.

The proposal is considered to preserve the character and appearance of the conservation area. Special attention has been paid to the desirability of preserving or enhancing the character or appearance of the Conservation Area, under s.72 of the Planning (Listed Buildings and Conservation Areas) Act 1990 as amended by the Enterprise and Regulatory Reform Act 2013.

No objections have been received prior to making this decision. The planning history of the site has been taken into account when coming to this decision.

As such, the proposed development is in general accordance with policies A1, D1 and D2 of the Camden Local Plan 2017. The proposed development also accords with the London Plan 2021 and the National Planning Policy Framework 2021.

Your proposals may be subject to control under the Building Regulations and/or the London Buildings Acts that cover aspects including fire and emergency escape, access and facilities for people with disabilities and sound insulation between dwellings. You are advised to consult the Council's Building Control Service, Camden Town Hall, Judd St, Kings Cross, London NW1 2QS (tel: 020-7974 6941).
