Variation of development granted under reference 2016/6088/P dated 30/06/17 for "Redevelopment of the existing Highgate Newtown Community Centre and Fresh Youth Academy and the change of use of the People's Mission Gospel Hall to provide replacement community facilities (Use Class D1) and 31 residential units (Use Class C3) with associated public open space, landscaping, cycle storage, plant and disabled parking."  Namely to make the following changes:  - Amend the height/bulk and massing, elevations  - Increase the number of residential units from 31 to 41  - Include 7 affordable units (intermediate) as opposed to none  - Reduce the area of the community facilities, to result in a smaller increase above the existing floorspace  - Remove most of the basement
- Include the existing right of way on the western side of the site.
