| Front Garden: T1: Mature Pear: Approximately 4.00-5.00m. Fell to ground level. Reason: The tree is in very poor condition. It is rather unsound, unlikely to regenerate and of low amenity value. T2: Mature Lilac - (adjacent to fence/trellis): Approximately 2.50m. Trim to tidy and reduce by up to 1.00m. Remove Ivy. G2: Hawthorn, Ivy & Pear Group: Approximately 8.00-9.00m: Reduce trees by up to 1.50m all round. Thin crown density throughout by 20%. Remove major dead wood. Sever Ivy at ground level and remove as is practicable. T3 & T4: 2 x Pines: Approximately 10.00m. Raise crowns over the lawn area by removing the lowest lateral branches to the east of the crowns, affectively lifting them by 1.50m. Reduce extraneous growth back into main crown structure by up to approximately 1.20m. Remove major dead wood throughout both trees. | |

T5, T6 & T7: 3 x Small Robinia Pollards: Approximately 2.00m. Fell to ground level and remove root balls.

Reason: The trees are weak with low vigour and poor crown structure.

S1: Photinia - (near Heath Drive gate): Approximately 5.00m. Prune hard back by 1.50-2.00m and allow to regenerate.

Reason: General maintenance as it is becoming woody, sparse and overextended.

T8: Acer: Approximately 8.00m. Remove Ivy throughout crown

T9 & T10: Chinese Privets: Approximately 6.00-7.00m. Prune hard back by 2.00m as part of a staged crown reduction to induce lower thicker growth which would provide lower screen and more light. Remove dead wood.

Reason: To increase light levels.

Reasons: General maintenance unless otherwise specified.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
 - o mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - o add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
