Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

The 3 Trees to be removed are young specimens. There is a new planting scheme in place,

The new planting scheme is designed to provide significant year round screening between the property and the adjoining neighbours who look out on to the garden.

The broadleaf trees are selected not only to provide year-round screening and greenery but also to be a rich source of nectar at various times of the year for pollinating insects.

The tree planting is part of significant garden redesign and client investment to provide greater areas of planting with more year round interest.

T1 – Prunus Cerasifera Nigra - Purple Leaf Plum - Young specimen with low amenity value - Fell to ground level and remove stump

Planting plan - Replace with an evergreen flowering tree such as a Azara Microphyllia

T2 – Prunus sp. - Cherry Tree - Young specimen - Poorly pruned with low amenity value - Fell to ground level and remove stump

Planting Plan - Replace with a standard 2m Evergreen Tree such as a Magnolia Grandiflora

T3 – Paulownia Tomentosa - Fox Glove Tree - Poorly pruned - Pollard at approx 2.5m creating a monolith to allow for re-growth

T4 - Silver Birch - Remove dead wood over Garden Flat only

T5 - Mimosa – Young specimen growing in enclosed raised bed pushing against the wall. Due to its poor location and infancy, this poorly planted tree will continue to cause problems for both the retaining and neighbouring walls and has outgrown its location. Fell to ground level and poison stump.

Planting plan - Replace with a suitable screening plant such as Eriobotrya

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

Sketch plan requirements

Your plan needs to show the precise location of the tree(s) in relation to nearby property/roads/boundaries. It should, therefore:

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
