The two trees will be removed. In order to mitigate the loss of T1 and T4, two new replacement trees will be planted, close to, or in their current position. The species of the replacement trees will be 1 x Liquidambar Styraciflua 'Lane Roberts' - Sweet Gum Lane Roberts and 1 x Acer Campestre 'Louisa Red Shine' - Field Maple Louisa Red Shine. See the arboricultural impact assessment for further details.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
