My application relates to a cherry tree in my front garden. It's very large and is destroying the drain at the base of it's trunk (see photos). The drain is now malfunctioning (leaves are coming in and my fear is that rodents can enter it. Repairs to the drain might slow up this issue but ultimately the trees position vis a vis the drain is always going to be a problem so it should be removed. We plan to plant other fruit trees in the back garden so, whilst we'll be loosing a tree on our plot we'll gain others that will be better situated.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
