PART A - DESIGN STATEMENT 1.0 Introduction

Located on the corner of Camden Street and Pratt Street the Greek Orthodox Cathedral is one of the first churches to be adapted for use by the Greek community in the 1940's, a community that has become one of the largest ethnic groups in London. The church sees over 1,500 people attend the Easter Saturday service annually, as well as performing hundreds of weddings, baptisms and funerals, as part of a growing orthodox community.

The church is of stock brick, with Bath stone dressings, portico and tower. The stone is Monks Park for columns and Stone Ground for ashlar work. The church, internally, comprises a large rectangular nave, with galleries around three sides supported on lonic columns, an apsed chancel and a circular vestibule flanked by stairs to the gallery. Twin vestries at the east end are linked by a semi-circular screen. There is a shallow brick vaulted crypt below the church. The chancel is screened by an iconostasis in accordance with Orthodox liturgy.

#### 1.1 Site Description


The church is Grade 1 listed. The grounds of the church are enclosed by metal railing and gates, with the land within used for car parking with primary access via Camden Street.



## Description:

Church, formerly Church of England, now Greek Orthodox. 1822-24. By W & HW Inwood. Yellow stock brick with stone east and west ends (west end painted); stone tower. Rectangular plan with apsed chancel in Greek Revival style. EXTERIOR: west end with tetrastyle in antis semi-circular portico of giant fluted lonic columns carrying an entablature which continues around the building, supported at west end angles by pilasters. Antefixae to cornice. Above the portico, a circular stone tower (based on the Choragic Monument of Lysicrates, Athens) with lonic columns supporting an entablature surmounted by a drum with clock faces and cross finial. 3 square-headed entrances with surrounds of pilasters, cornicehead and round-arched architrave; C20 wooden doors and reeded panelling above. North and south facades with architraved round-arched windows having square-headed surrounds. East end apse with round-arched windows linked by impost bands. INTERIOR: with flat ceiling; 5 bays with lonic columns supporting galleries on 3 sides. Classical decorative detail inspired by Henry William's travels in Greece. Chancel and nave now separated by iconostasis. HISTORICAL NOTE: originally built as a chapel of ease to serve Lord Camden's new developments, it was known as the Camden Chapel and only dedicated to All Saints in 1920. #### 11.0 Introduction

All Saints Greek Orthodox Cathedral is an early 19<sup>th</sup> century Grade I Listing building in the London Borough of Camden.

#### 12.0 National and Local Planning Policy

The relevant heritage references are within the following:-

- a) Historic Environment Good Practice Advice in Planning Notes.
- b) Conservation Principles Policies and Guidance For The Sustainable Management Of The Historic Environment'
- c) National Planning Policy Framework (NPPF)

#### Historic England's Conservation Principles.

The suggested approach in providing a decision is to provide a comprehensive framework for the sustainable management of the historic environment.
