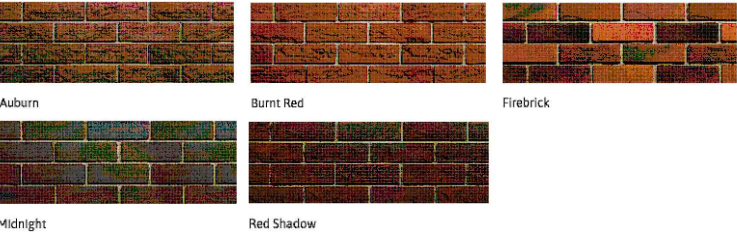

Our preferred option would be the **Red Shadow**



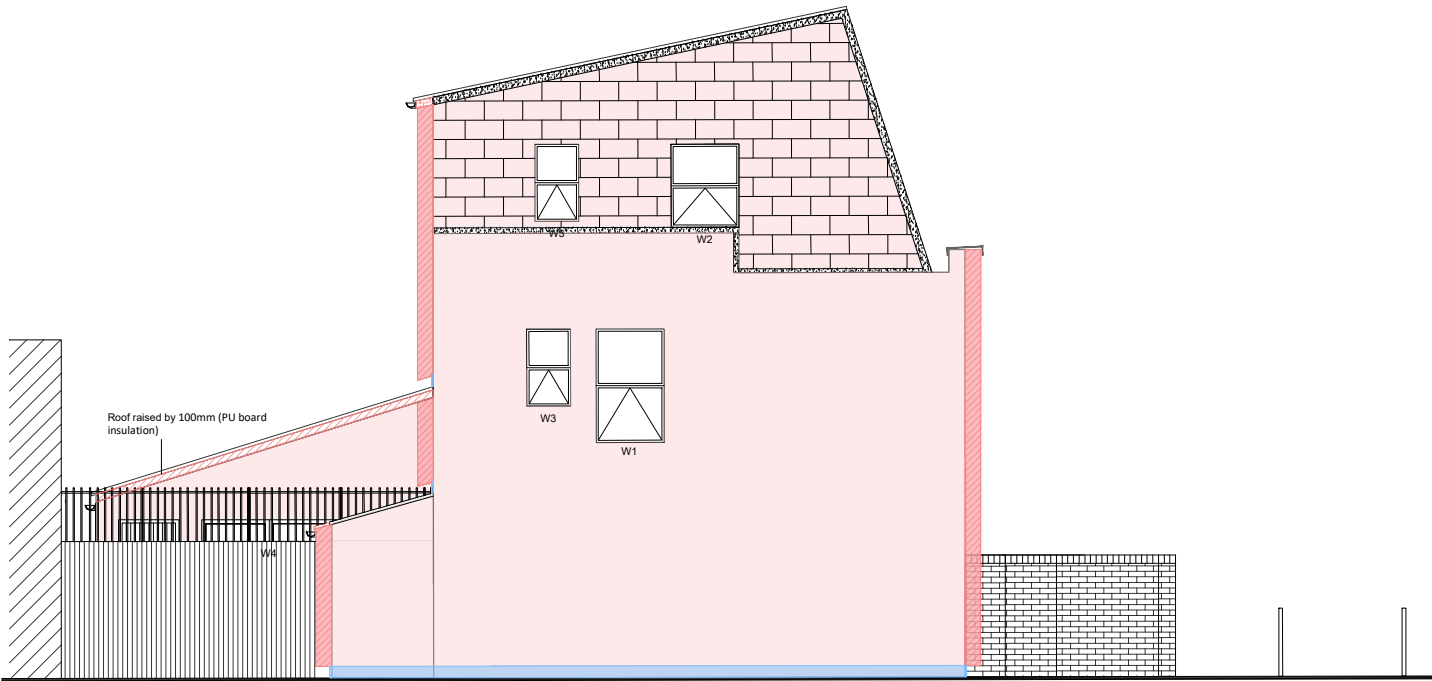

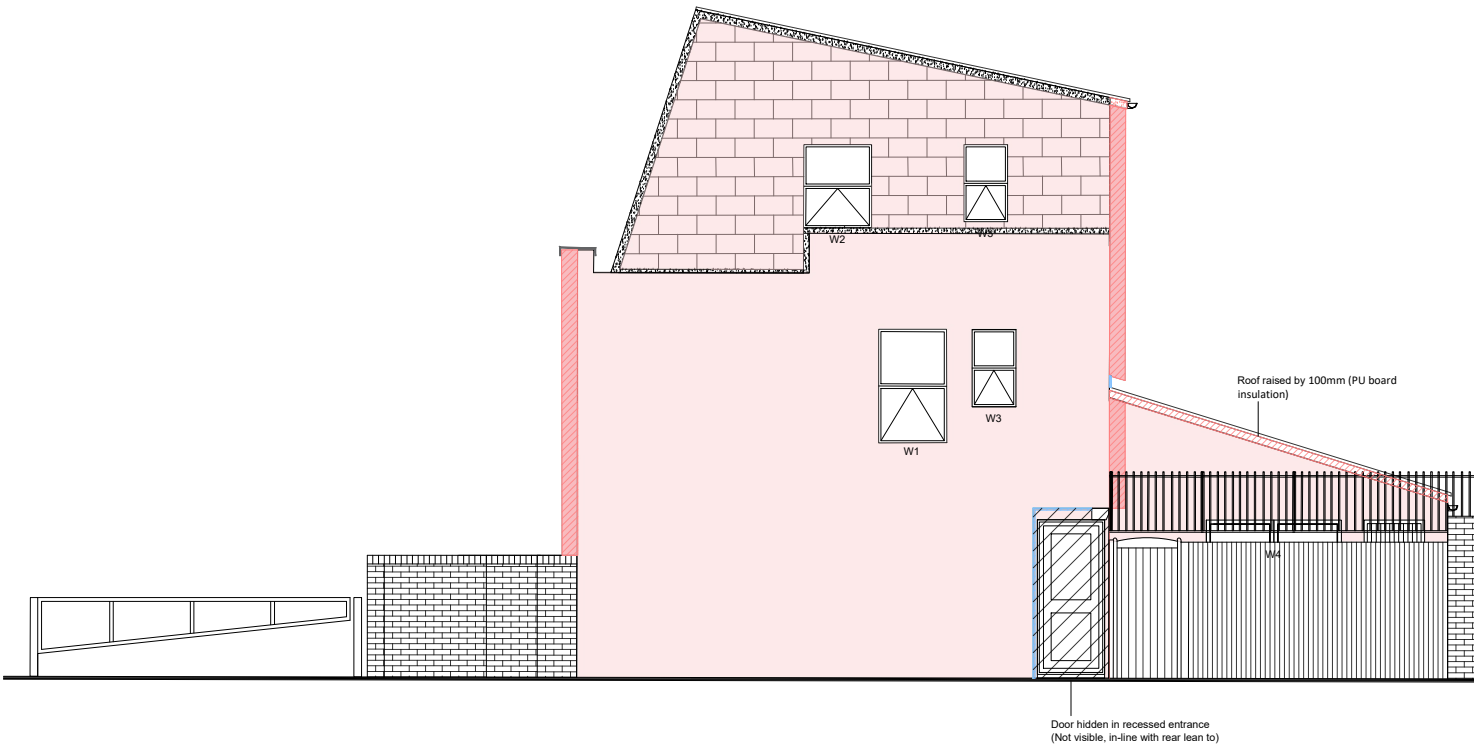

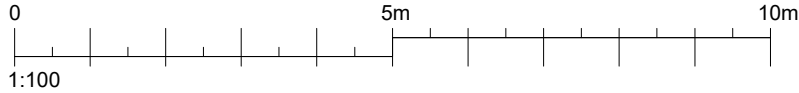
PROPOSED SIDE STREET SCENES 1 - 6 BROOKES COURT - SOUTH:
