The planning application 2022/2452/P in respect of the Ladies' Pond focuses on "security" and infrastructure used to enforce payment by swimmers but much of the accompanying documentation still appears to highlight improved accessibility. This is misleading.
				I am particularly concerned about the accessibility of the buildings.
				• The Ladies' Pond buildings went up in 2016 with planning permission from Camden Council, but they were non-compliant for disability access. The City of London ignored feedback from users and lifeguards at the time. A report commissioned by the City of London in 2018 confirmed the non-compliance and recommended building a new section to house compliant WC and shower facilities. The City of London is instead going for the cheaper again of carving out an accessible WC-shower room in the existing building's spaces. I would like this done properly instead.
				• The City of London is planning to make adaptations to the changing room buildings before addressing the underlying damp and drainage issues. This will be self-defeating as any adaptations are likely to fail if these problems are not resolved first. The buildings are likely to remain non-compliant if these adaptations fail. This appears to breach the aims of the Camden Local Plan in respect of accessibility.
				• Fundamental problems with drainage and damp still need to be addressed properly, and currently put both staff and swimmers at risk e.g. through the presence of black mould. Perhaps you'd like to get your environmental inspectors in.
				• It looks like the proposed new WC-shower room will still not comply with Changing Spaces standards. The plans submitted with the application are ambiguous about any measurements.
				• The combined WC-shower will reduce availability of an accessible toilet when in use as a shower and changing room. This is totally unacceptable. The planned put grab rails in one of the existing cubicles of the main toilet block will be of limited use, and will not meet accessibility standards.
				• Overall, the failure to address accessibility in a logical manner appears to be a breach of the requirements of the Camden Local Plan in respect of planning applications.
				• A test of relevance was not produced before any consultation with user groups, about adaptations to the building. Then no test of relevance or Equality Impact Assessment is included with the planning application 2022/2452/P, despite a claiming that a significant part of the works across the Heath being to improve disability access.
