Lime tree in the front garden, visible from the road. Overdue routine maintenance. Tree is about 12-15m high and 6-9m wide. Propose to reduce back to previous reduction points, i.e. re-pollard, removing 1-4m regrowth. Tree was last maintained over six years ago in 2016.		
You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
