## Town and Country Planning Act 1990 (as amended) NOTIFICATION OF AN APPEAL

The Council has been notified of an appeal against the Council's enforcement notice, which has been made to the Planning Inspectorate. The appeal concerns property at: **Flat 3** 

10 Hilltop Road London NW6 2PY

and the breach of planning control alleged in the enforcement notice is:

## Without planning permission: Replacement of timber sash windows with 3 x white UPVC windows on the front elevation at first floor level.

Grounds of Appeal

The appellant/s have appealed on the following grounds:

a) That planning permission should be granted for what is alleged in the notice.	( <b>x</b> )
b) That the breach of control alleged in the enforcement notice has not occurred as a matter of fact	( )
c) That there has not been a breach of planning control.	( <b>x</b> )
d) That, at the time the enforcement notice was issued, it was too late to take enforcement action against the matters stated in the notice.	
e) Copies of the enforcement notice were not served on everyone who has an interest in the land. ()	

f) The steps required to comply with the requirements of the notice are excessive, and lesser steps would overcome the objections. (x)

g) The time given to comply with the notice is too short.

The appeal is to be decided by an Inspector from the Planning Inspectorate on the basis of an exchange of written statements between the people who have made the appeal and the Council, followed by a site visit.
