## Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

Rear Garden:

T1: Mature Magnolia: Approximately 6.00m-7.00m: Reduce crown height by approximately 1.00m (preserving screen for 1st floor window). Reduce wayward rose stems back. General maintenance.

T2: Small Acer: Approximately 5.00m: Left hand boundary: Reduce crown by approximately 0.50m. Thin upper crown density by 20%.

T3: Big Birth: Approximately 11.00m: Near boundary: Thin crown density by 15%-20%. Reduce lateral and sub lateral branches back from the building by up to 1.00m. General maintenance.

T4: Smaller Birch: Approximately 10.00m: Rear Boundary: Thin crown density by 15%-20%. Reduce back from neighbouring garden by approximately 1.00m. Control encroachment.

S1: Trachelospermum: Growing on rear wall of the house: Trim face hard back to tidy and control as is practicable. Reduce high advancing stems back into main plant structure. Control encroachment.

S2: Griselinia: Approximately 5.00m: Reduce by approximately 40% (2.00m) trim back lateral growth by approximately 30-50cm. General maintenance.

G1: Magnolia Grandiflora: Approximately 7.00m-8.00m: Forming hedge line: Reduce lateral and sub lateral branches growing over neighbouring property by approximately 1.00m. Control encroachment.

T5: Large Bay: Approximately 7.00m: Reduce height by up to 1.50m. Reduce lateral and sub lateral branches by up to 30cm. General maintenance.

T6: Small Bay: Approximately 3.50m: Reduce rear branch back into main crown structure approximately 2.50m reduction. Reduce remaining crown by approximately 1.50m to reshape. General maintenance.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

Where trees are protected by a Tree Preservation Order, please number them as shown in the First Schedule to the Tree Preservation Order where this is available. You should use the same numbering on your sketch plan (see below for sketch plan requirements).

e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

### Sketch plan requirements

Your plan needs to show the precise location of the tree(s) in relation to nearby property/roads/boundaries. It should, therefore:

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
  - mark and name surrounding roads
  - sketch in buildings, including adjoining properties
  - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - marking all trees on the plan, but only numbering those to which you want to carry out work
  - showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
