The property currently has an existing single-story rear side extension, which extrudes 2.8m from the existing main building, 4.26m in width and 3.08m in height. Currently, it serves as a very small living & dining room with direct access to the garden. The internal maze of separating thick existing loadbearing wall make most areas and rooms very dark, encapsulating and segregating.

The proposed extension to the existing rear garden, later a non-original extension, proposes a slight reconfiguration of the internal layout that will create a more bright and well illuminated, open and less segregating living, dining and kitchen area. It extends 1.93m towards the rear garden and 0.9m on both sides up to the boundary fence walls of the existing extension while keeping the same height. This proposed extension adds new 13.7 sq meters to the original GIA.
