Hi Kate,

I have been provided this information and the attached list of proposed planting. Please let me know if you need anything else.

Planting and top soil £9000

The planting will be a mixture of evergreen structural planting interplanted with pretty perennials and grasses, mostly in whites, purples and pinks. Bark mulch will be installed after the irrigation is laid to feed the soil and suppress the weeds and gravel will be laid around the building to make it accessible and aid drainage. The boundaries will be planted with scented evergreen insect friendly climbers such as Hedera and Trachelospermum. The small trees have been chosen for their suitability for small city gardens, early flowers, interesting foliage and autumn colour.

All plant cultivars are subject to availability, substitutions may be made.


