This application seeks to fell the existing Contorted Willow tree (T1) and replace with an upright Cherry tree or similar.

The existing tree (T1) is not suitable species for the location and is overgrown, thereby straining the structural integrity of the shared party fence wall.

Existing tree (T1) is not visible from the public realm. However, it will be replaced to maintain the biodiversity of the area. Suitable root barriers around the replacement tree would be installed, as well as implementing a maintenance regime to safeguard the integrity of the party fence wall.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
