T1 - lime tree (14m) - lift overhanging branches and ivy to approximately 5m from ground level and back to boundary.		
T2 - lime tree (14m) - lift lower overhanging branches to approximately 5m from ground level and back to boundary, reduce higher overhanging branches (over 6m) to previous pruning points, approximately 4m reduction.		
T3 - lime tree (14m) - no work.		
T4 - lime tree (5m) - reduce overhanging branches back to boundary, 3m prune.		
T5 - lime tree (7m) - reduce overhanging branches back to boundary, 3m prune.		
T6 - hawthorn tree (8m) - lift crown to 3m from ground level and reduce branches growing towards building to create at least 1.5m clearance.
