## Rear Garden:

T1: Mature Oak: Approximately 23.00m:Thin crown density throughout by approximately 20%. Remove epicormic growth from main stem. Remove dead wood and unused drays. Where necessary, reduce overlong branches on house side back into main crown structure to control encroachment. Reduce overlong lateral and sub lateral branches back into main crown structure not more than 2.00m reduction of any branch. General maintenance.

T2: Cotoneaster: Approximately 5.00m-6.00m: Reduce crown by approximately 1.50m all round. General maintenance.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
