T1. London Plane - Reduce lower to mid crown overhanging Haverstock Hill by up to 3 metres Reduce large main limb over car park by up to 3 metres. Prune back from building to maintain 3m clearance.

 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
