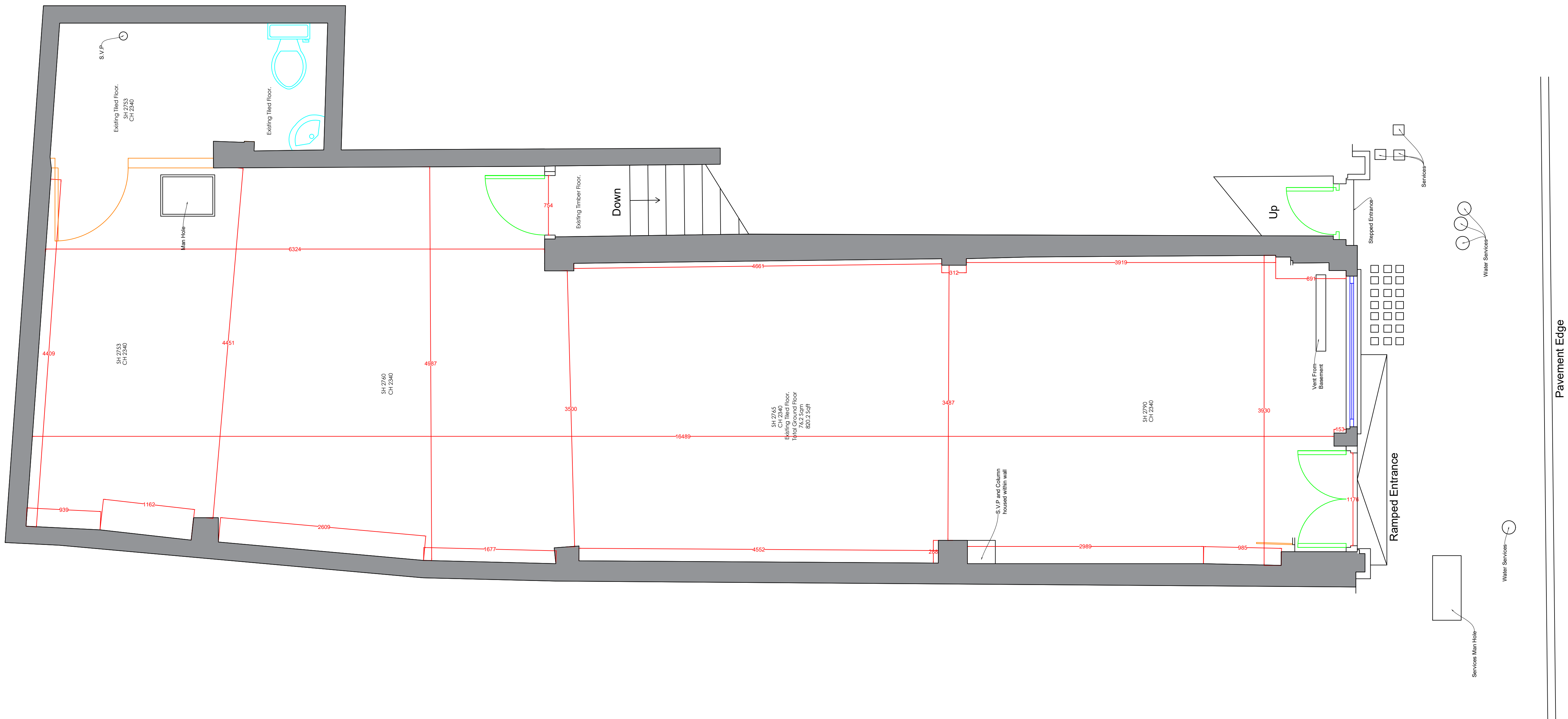


- PLEASE NOTE:**
