Front of no5 Bacons Lane

T1 Dead Tree x 1 Suggested works:- Fell to ground level

- Grind down stump 300mm below ground level

Rear garden of no5

T2 Fig x 1 (Ficus carica) This tree is growing extremely close to property.

Suggested works:

- Fell to ground level
- Poison stump to prevent re-growth
