Proposed Work:

FRONT GARDEN: 1 x Pear (T1) - Fell to ground level. 1 x Lilac - (T2) - Trim to tidy and reduce by up to 1m.

Group of Hawthorn, Ivy & Pear (G2) - Reduce trees by up to 1.5m all round. Thin crown density throughout by 20%.

- 2 x Pines (T3 & T4) Raise crowns over the lawn area by removing the lowest lateral branches to the east of the crowns, lifting by 1.5m. Reduce extraneous growth back into main crown structure by up to approx 1.2m.
- 3 x Robinias (T5, T6 & T7) Fell to ground level and remove root balls.
- 2 x Chinese Privets (T9 & T10) Prune hard back by 2m as part of a staged crown reduction to induce lower thicker growth.

The Council has considered your notification of intended works to trees dated 13 July 2022 and does not wish to object.
