We want to add a balustrade (railing) along the edge of the flat roof on the 2nd floor of the house at the rear (facing our garden).

The main purpose is to ensure our safety whenever we venture on the flat roof to clean the gutters, repair windows, roof or aerials. We can only access the flat roof through our two sash windows. We may very occasionally use it to take some fresh air in the summer.

We have just completed insulation works to the flat roof on the 23rd of August (with 75mm foil board insulation as a warm deck roof, a new waterproof cover and trims). It was letting cold air enter the house in the winter and we wanted to improve energy efficiency of the house. During these works, we added brackets to the flat roof insulation in order to be able to add a balustrade as soon as planning is agreed.

The balustrade would be in Victorian design and made from cast aluminium, please see an image attached, and the handrail and base rails will be in mild steel. The railings would be 1100mm high at least in order to comply with building regs.

Please note that many of our neighbours on Goldhurst terrace have such railings (whether they own the full house or it's a conversion), including our immediate neighbours on 166, 164, 162 and 172 Goldhurst Terrace.
