**Job Title:** Mental Health Social Worker – North Camden Recovery & Rehabilitation Service (NCRR)

### About Camden

As a Social Worker in North Camden Recovery & Rehabilitation Service, you will form part of a large network of professionals in an integrated Mental Health setting. Mental Health support in Camden is provided in joint partnership and collaboration between Camden Council and Camden & Islington NHS Foundation Trust.

### About the role

In this role, you will work as part of a multi-disciplinary group of professionals who use their collective skills sets to assess and plan interventions with people with mental illness as well as their families and other support networks. The Social Work voice is integral in the integrated setting, and you will represent your profession and contribute your unique expertise and skill set to provide holistic support to those in our communities who need it most.

At the core of the role is the unique ability to develop long term relationships with people and their support networks to help them build the lives that really matter to them and to maintain good mental health. Your approach will need to be strength – based in nature with a strong focus on the core values of your Social Work role as well as being recovery focused.

At times, unexpected events and crisis may arise and your ability to recognise and respond to signs of harm, abuse and neglect is pivotal in keeping those who are most vulnerable safe from harm whilst avoiding unnecessary admission to hospital whenever possible.

You will have the opportunity to practice and develop a wide range of skills including the opportunity to coordinate Mental Health Act assessments and participate in the Camden's AMHP duty rota or be willing to train as an AMHP.

### About you

It is essential that you have a BA, BSc, DIPSW or CQSW or MA in Social Work or equivalent qualification and that you are registered with Social Work England. You must be willing to undertake post qualifying courses when required such as the Approved Mental Health Professional (AMHP) qualification.

The role requires a working knowledge of, and experience in Mental Health Services including familiarity with the support options, interventions and resources for those with mental ill health. You must have a keen interest in working with mental health and be professionally curious about the area of work

A thorough knowledge of the relevant legislation (e.g. MHA, MCA, Care Act etc), policies, procedures and best practice guides is essential in this role and there is a continued need for professional development.

**Work Environment:**

The role is office based but the ability to do some flexible working.

**People Management Responsibilities:**

This role does not involve people management responsibilities but there will be opportunities for mentoring or supervising staff or students within the service.

**Relationships:**

You will join an integrated Mental Health Service and will have daily contact with a variety of professionals with different skill sets and expertise to contribute to the holistic support of people with ill mental health. You will also have the opportunity to develop and maintain professional relationships with people, their carers, families, other professionals, the public and wider community networks.

It is essential that you work collaboratively with those people receiving input from Mental Health Services as well as their networks and other professionals to ensure excellent service delivery with minimal delays.

You will work across Camden Council as well as Camden & Islington NHS Foundation Trust as per a Section 75 agreement and will need to build and maintain strong working relationships across the two organisations as you work towards a shared set of goals.
