- Indicates new walls and any other new construction elements

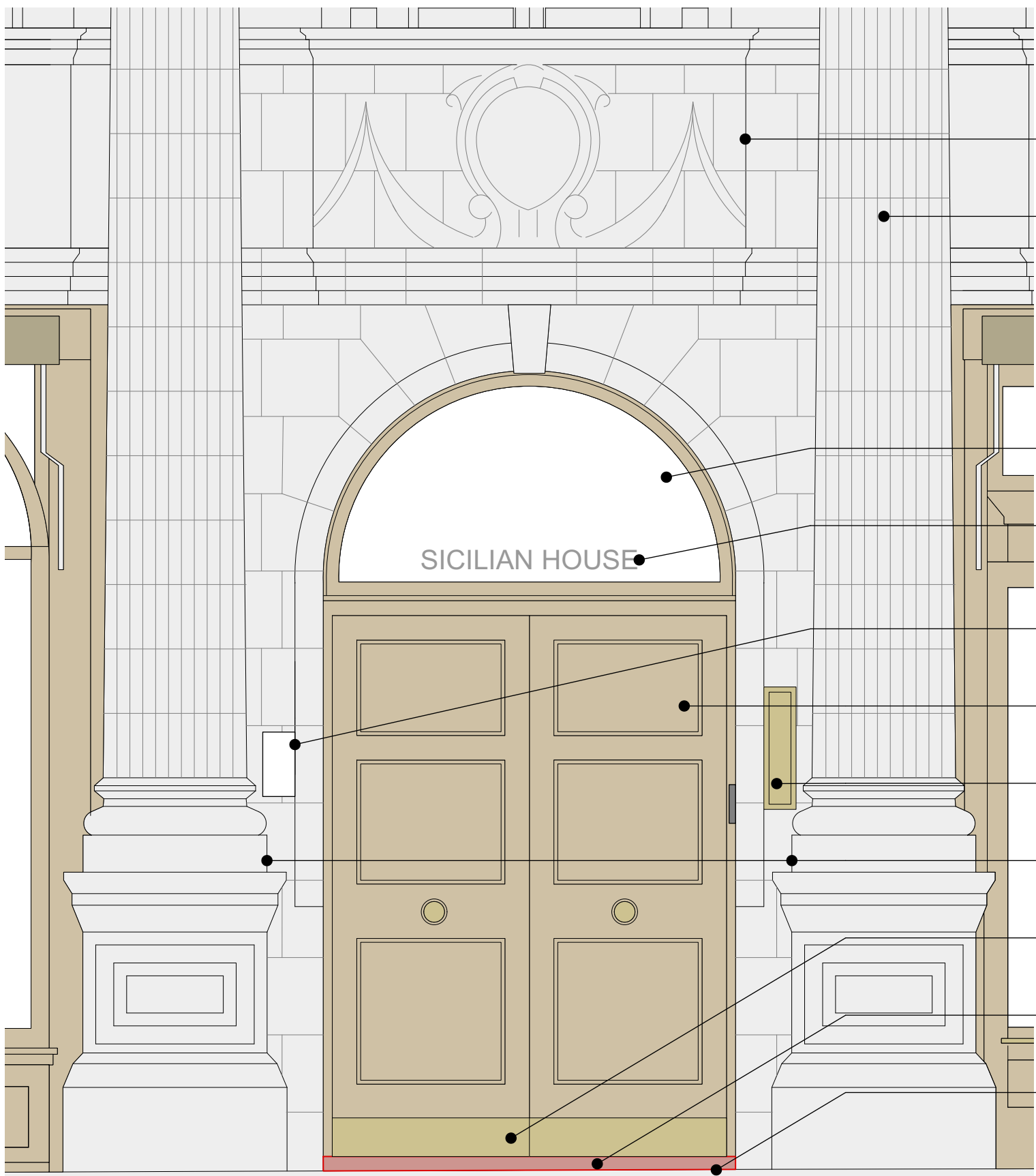

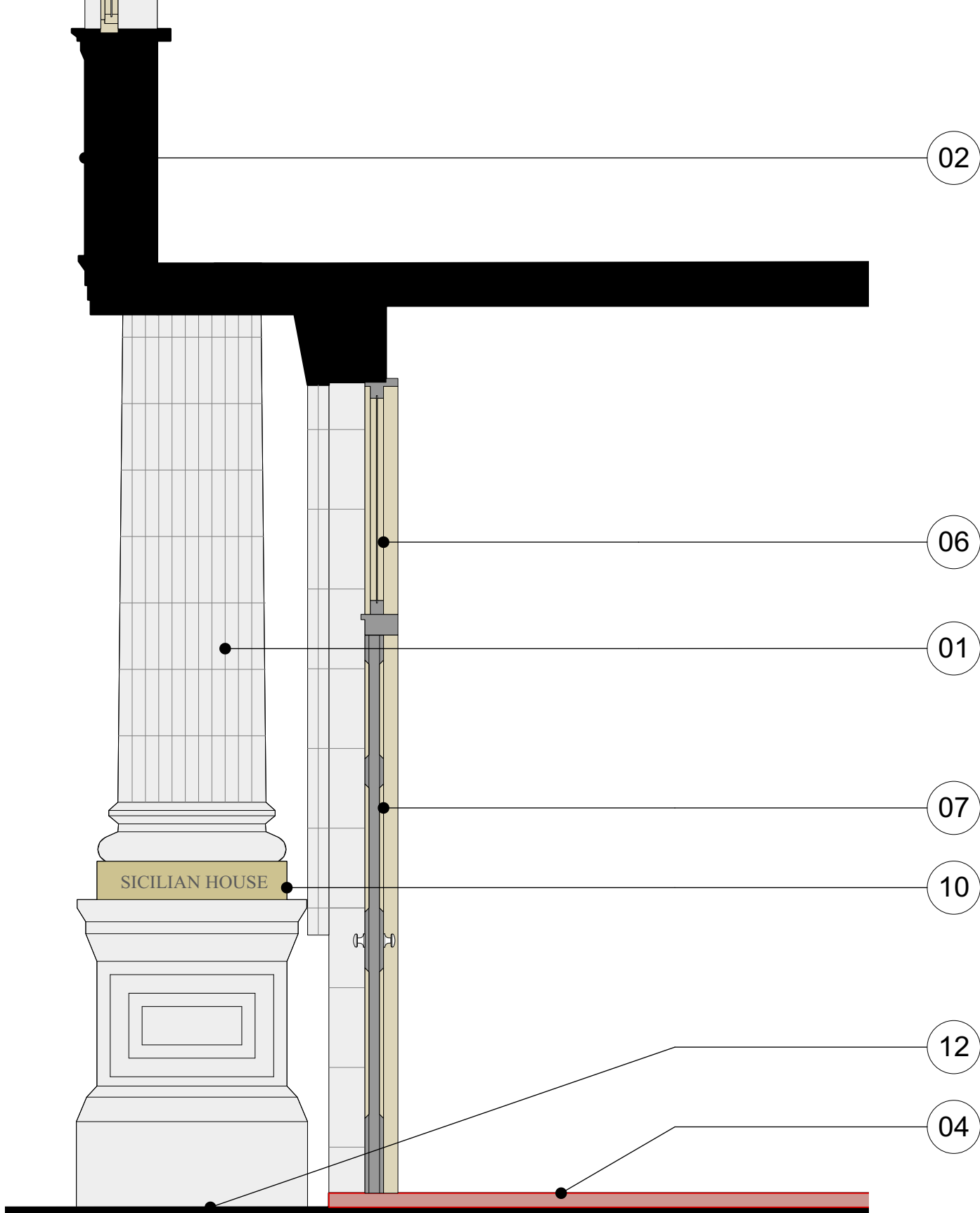

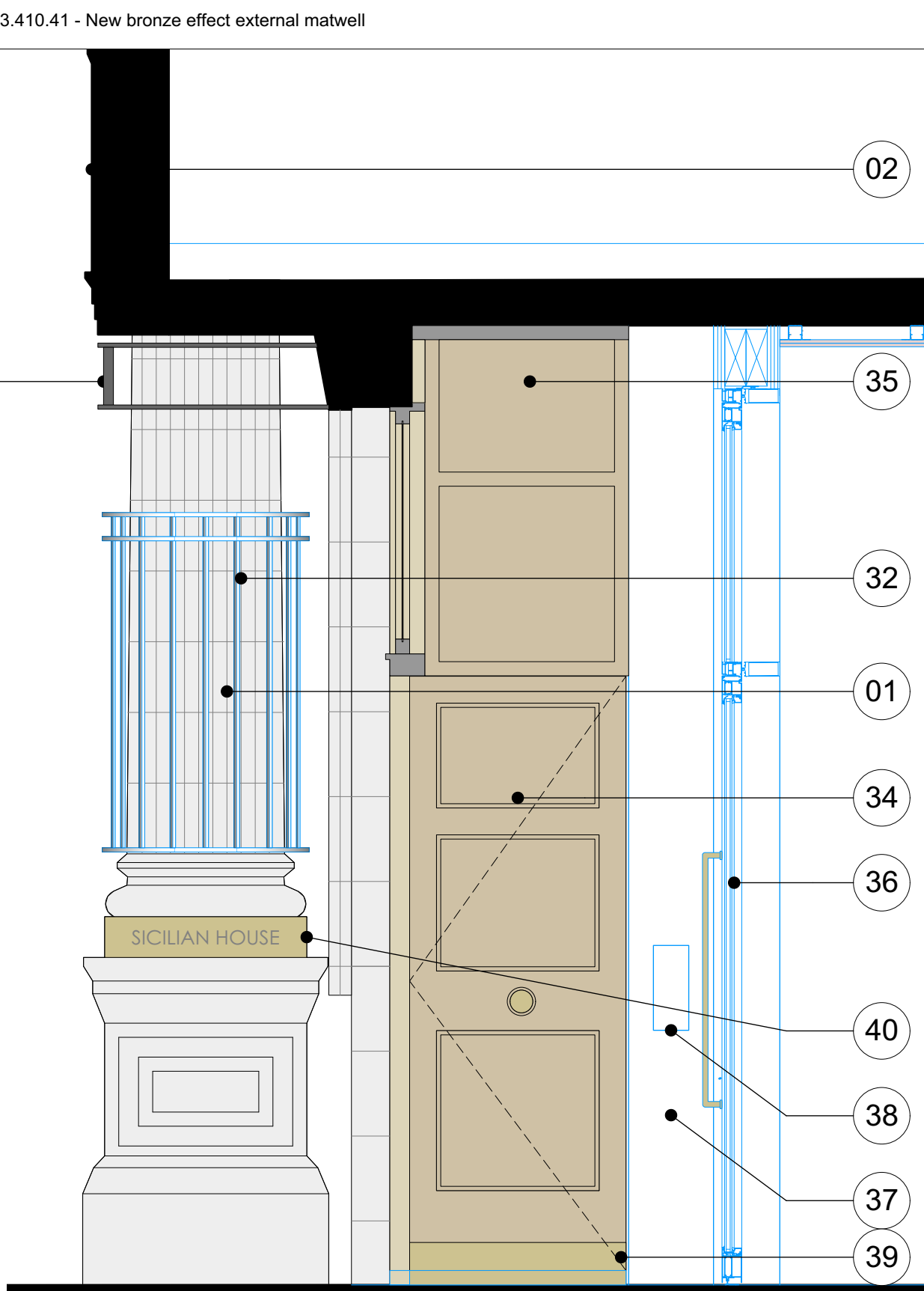
1 Sicilian House Entrance Demolition Elevation

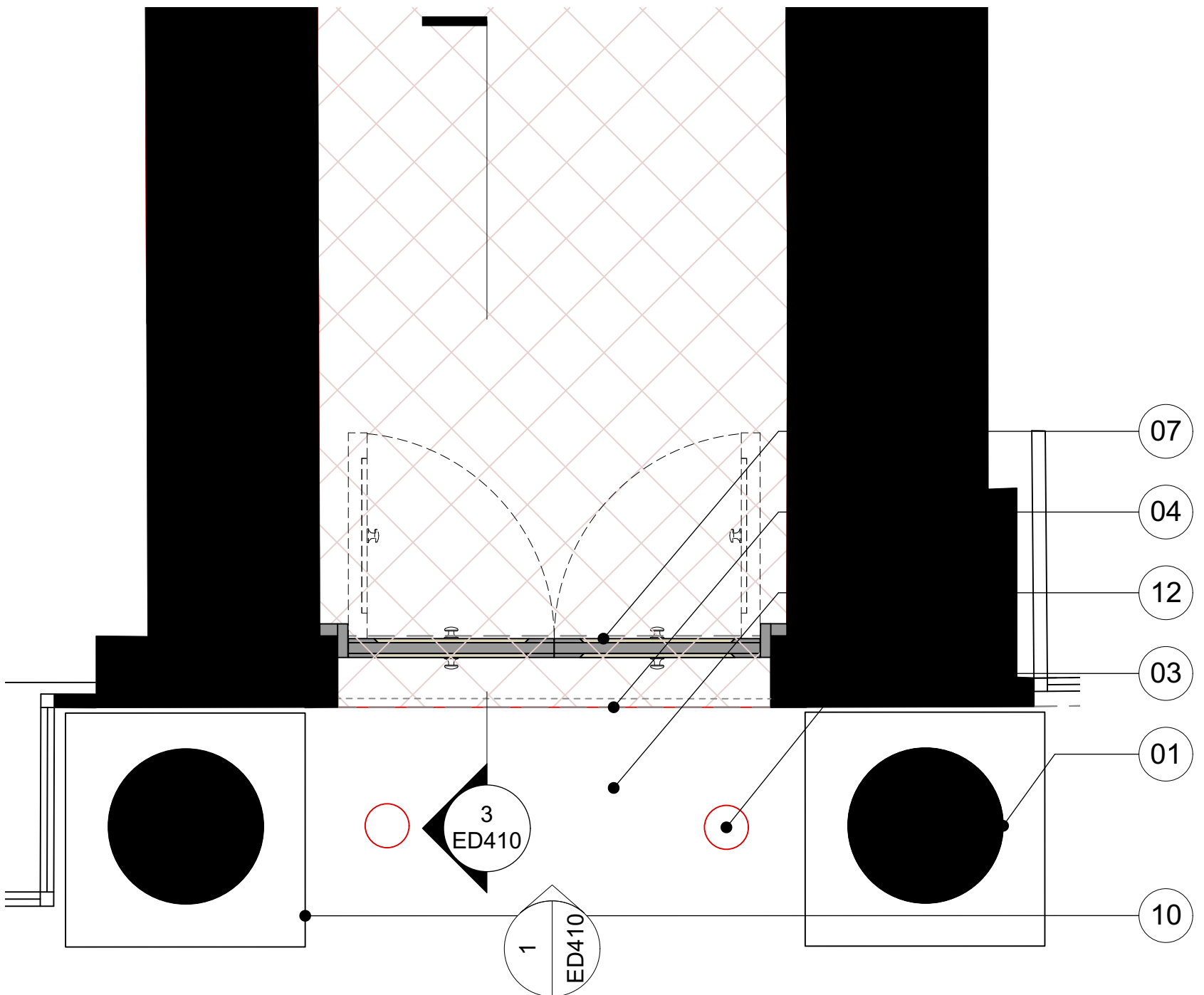
3 Sicilian House Entrance Demolition Section
Scale: 1:20



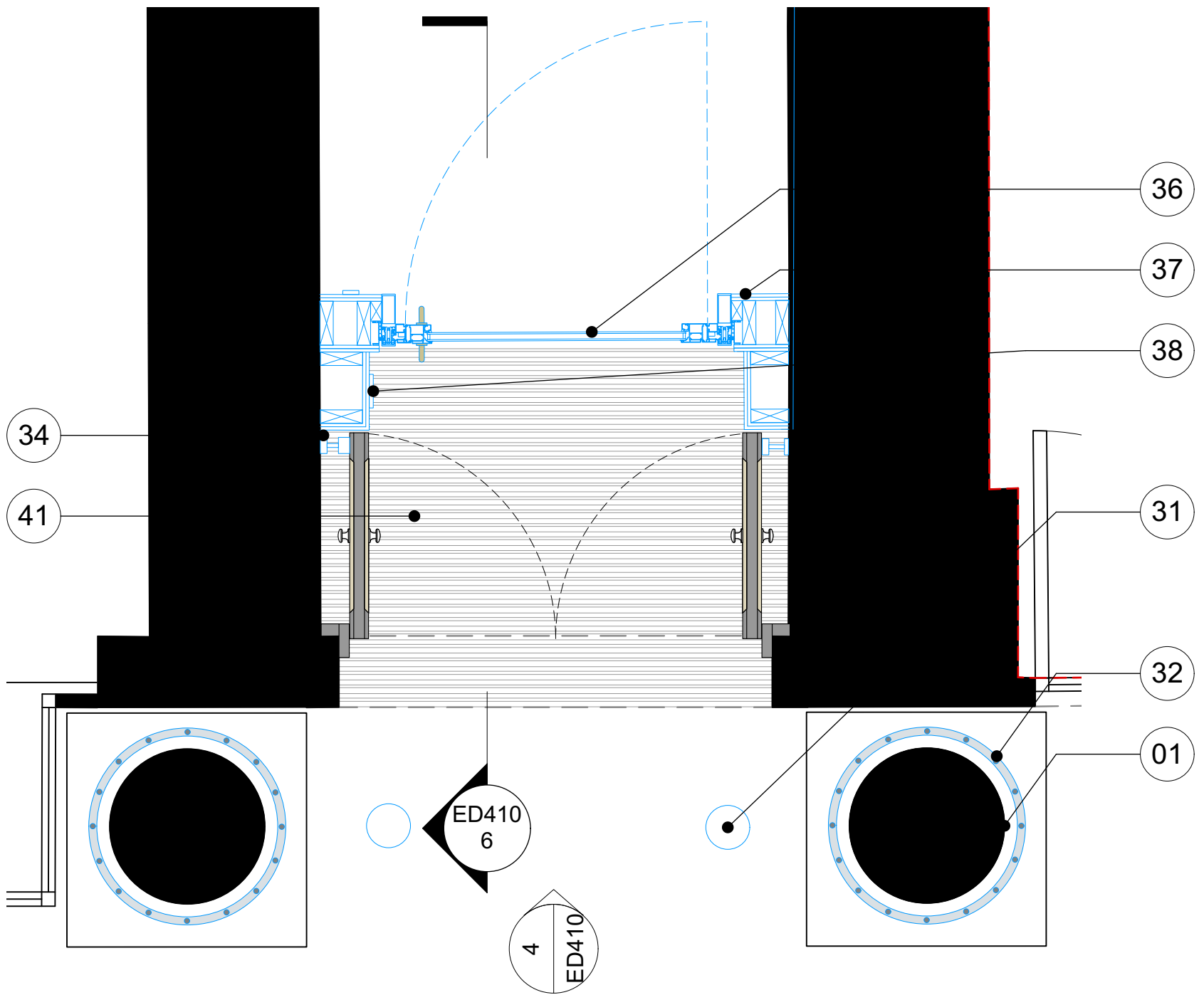
4 Sicilian House Entrance Proposed Elevation

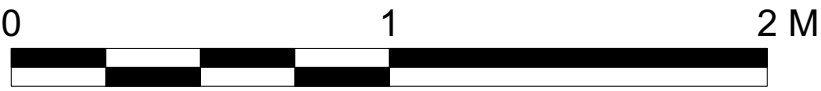
6 Sicilian House Entrance Proposed Section
