Rear Garden:

Left hand boundary:

- T1: Semi-Mature Cox Apple: Approximately 5.00m: Reduce height by up to 2.00m. Thin crown density by 20%. Remove dead wood throughout crown. General maintenance.
- T2: Small Acer: Approximately 4.00m: Reduce crown by approximately 1.00m. Thin crown density throughout by 20%. General maintenance.
- T3: Mature Norway Maple: Approximately 12.00m: Reduce crown by approximately 2.00m all round. Thin crown density throughout by approximately 20%. Remove deadwood throughout. General maintenance.
- T4: Mature Bay: Approximately 8.00m: Reduce crown height by approximately 2.00m to approximately 6.00m. Reduce lateral and sub lateral growth by up to 1.50m to balance and shape. General maintenance.
- T5: Cherry tree: Growing within the curtilage of No.3 and overhanging No.5: Reduce lateral and sub lateral branches overhanging No.3 by approximately 1.50. To help control encroachment.
- T6: Semi-mature Apple: Approximately 4.00m: Reduce crown by up to 1.25m. Thin crown density by 20-25%. Remove dead wood throughout crown. General maintenance.
- T7: Hazel: Approximately 4.00m: Partial coppice. Remove major stems. preserve minor secondary growth. General maintenance.

Right hand boundary:

- T8: Semi-Mature Apple: Approximately 4.00m: Reduce crown by 20%. Thin crown density by 20%. Remove dead wood. General maintenance.
- T9: Mature Bramley: Approximately 8.00m: Reduce crown density by approximately 1.50m all round. Thin crown density by 20%. Remove dead wood throughout crown. General maintenance.
- T10: Mature Purple Plum: Approximately 7.00m. Reduce crown by 20%. Remove deadwood throughout crown. General maintenance.
- T11: Mature Mulberry (Previous pollard): Approximately 8.00m: Reduce crown by approximately 1.20-1.50m. Thin crown density by 25-30%. General maintenance.
- T12: Ash Sapling: Approximately 5.00m: Fell and treat with systemic herbicide. Fast growing potentially very large specimen growing very close to shed. Control encroachment.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

## Sketch plan requirements

Your plan needs to show the precise location of the tree(s) in relation to nearby property/roads/boundaries. It should, therefore:

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
  - o mark and name surrounding roads
  - o sketch in buildings, including adjoining properties
  - o add house numbers or names

**Tree Ownership** 

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - o marking all trees on the plan, but only numbering those to which you want to carry out work
  - showing the approximate distance between the application tree(s) and buildings
  - o adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
