x1 Birch (B. utilis) & x1 Walnut (J. regia) in rear garden.

Works: x1 Birch (cpkrd.n3 on location plan) - cut back of side elevation of 22 South Villas to provide minimum 1-2m clearance.

x1 Walnut (cpkrd.n1 on location plan) - fell to ground level and replace with suitable species, spatially further from 22 South Villas Reason: x1 Birch - general arboricultural management

x1 Walnut - the tree has been planted hard against rear brick boundary wall in artificially raised soil bank. Wall was never constructed as a retaining wall but is now and is cracked with horizontal distortions towards 22 South Villas. Tenants at 22 South Villas are unable to close nearby side access gate because of distortions. Concerns the wall will collapse into side access for 22 South Villas.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
