T1: Sycamore - Thin throughout the crown by 15%

#### T2: Sycamore - Thin throughout the crown by 20%

Reduce the extremities of the branches growing towards the neighbouring property (east side) by 2-2.5m

T4: Sycamore - This tree has a heavy lean to the south and as T3 is being removed due to extensive decay at the base, the structural integrity of this tree will be

#### somewhat compromised

Crown reduce the height and spread by 33% (approx. 4-5m height and 3m spread)

Maintenance works in line with good Arboricultural practice

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - marking all trees on the plan, but only numbering those to which you want to carry out work
  - $\circ~$  showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)
