Rear Garden:

T1: Medlar Tree: Approximately 7.00m: Thin crown density by20%. Reduce lateral and sub lateral branches by approximately 1.20m all round to form a more compact crown structure. General maintenance.

T2: Mature Bay: Approximately 9.00m: Reduce lateral and sub lateral growth by approximately 0.5m-1.00m to form a more columnar crown structure. Thin crown density by 20%. General maintenance.

T3: Mature Apple: Approximately 7.00m: Fell to ground level and remove root ball. Re-landscaping - Tree to be replaced with a pear tree.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
