Tree type - Turkey Oak ( Quercus cerris)

Approx Height - 17m

Approx Crown Spread Diameter - 9m

Location - rear garden

Service - Crown Reduction

Work required- To crown reduce all over by approx 2-2.5m back to previous pruning points and thin crown by 25 %

Reason - as per clients instructions to allow more light into surrounding properties and shrubbery

P.N client has raised concerns that the tree is causing structural damage to surrounding walls and property, to ascertain the cause of this problem and to rule out the tree is not the issue I would recommend a structural engineer to give a full report to conclude their findings.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - marking all trees on the plan, but only numbering those to which you want to carry out work
  - showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)
