T1- Maple tree- finish pruning of tree, prune back branches overhanging garden of 5 Lyme street back to previous pruning points and reduce height back to previous pruning points (up to 4m reduction).

The proposed work is part of ongoing tree management. The branches over the neighbouring gardens have been pruned in the last 3 months. This side of the tree needs to be pruned to balance the tree.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
