Lime T1 (22M high, 800mm dia.) - Reduce the crown of the tree overall by up to 3 metres and back to the previous points of reduction.		
Rear Garden:		
London Plane T2 (20M high, 850mm dia.) - Raise crown droppers to 8 metres above garden level. Light thin of inner crown by up to 20%.		
You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
