The proposed works involve the removal of an existing window to the rear of 9 Collard Place. The existing structural opening will be retained and the lintel will remain. The section of brickwork below the window opening will then be removed and taken down to floor level to allow for new door opening. The surrounding brickwork will be made good, cavity closers, DPC's and insulation to be made good to conform to building regulations. A new timber frame glazed door will be installed within the opening. The timber will be painted white to match existing or similar on site. A local FENSA approved contractor will be used for the brickwork alteration and door installation.
