Proposed Work:

REAR GARDEN: 1 x Holly (T1) - Fell to ground level.

1 x Holly (T2) - Reduce approx. 2.5m off the top.

1 x Prunus (T3) - Fell to ground level

1 x Pear (T4) - Reduce approx. 2m off the top and approx. 1.5m reduction on all sides.

1 x Fig (T5)- Reduce approx. 1m off the top and approx. 1.5m reduction on all sides.

1 x Sycamore (T6) - Reduce approx. 3m off the top and approx. 1.5m reduction on the sides, pruning back the sides by approx. 1.5m from the brick wall.

1 x Ash (T7) - Reduce 3m off the top and approx. 1.5m - 2m reduction on the sides, pruning back the sides by approx. 3m from the brick wall.

The Council has considered your notification of intended works to trees dated 12 August 2022 and does not wish to object.

- 1 This notice is valid for 2 years from the date of this letter or until the work is completed, whichever is the sooner.
- 2 You are advised that the appropriate standards for tree work are set out in BS

3998: 2010. Failure to ensure that the proposed works are carried out to these standards may result in damage to the tree(s) and may result in legal action by the Council.

- 3 Please note that any approval given by the Council does not give an exemption from the requirements to comply with the Wildlife and Countryside Act 1981 (as amended), or any other Acts offering protection to wildlife.
