The Council has considered your application and decided to grant permission subject to the following condition(s):

### Condition(s) and Reason(s):

1 The development hereby permitted must be begun not later than the end of three years from the date of this permission.

Reason: In order to comply with the provisions of Section 91 of the Town and Country Planning Act 1990 (as amended).

The development hereby permitted shall be carried out in accordance with the following approved plans: 1000 S4 Revision P01; 2200 S4 Revision P02; 2400 S4 Revision P02; 2401 S4 Revision P02; 2402 S4 Revision P02; 2403 S4 Revision P02; 2404 S4 Revision P01; 2405 S4 Revision P01; Typical Weight Balance Sash Slimlite Window; Typical Spiral Balance Sash Slimlite Window; Integrated Glazing Bar Window Detail; Design and Access Statement dated February 2022.

Reason: For the avoidance of doubt and in the interest of proper planning.

All new external work shall be carried out in materials that resemble, as closely as possible, in colour and texture those of the existing building, unless otherwise specified in the approved application.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policies D1 and D2 of the London Borough of Camden Local Plan 2017.

# Informative(s):

1 Reasons for granting permission.

The proposed replacement windows and door would match as closely as possible the existing windows and door in terms of materials, colour, design, opening methods and proportions.

There would be some degree of increased thickness to the frames/glazing bars in order to accommodate the double glazing panes; however, in this instance, the use of suitably designed slim-line units are considered to be an appropriate and sympathetic change which would result in an overall improvement in the character and appearance of the host building and wider Belsize Park Conservation Area.

In sustainability terms, double glazed units are noted as having the potential to reduce energy costs, provide more thermal efficiency and insulation, offset the need for powered heating and so reduce carbon emissions, and allow for passive flow of ventilation (through trickle vents).

There are no amenity concerns to neighbouring properties given the proposal would replace existing building features and fenestration.

The site's planning and appeals history has been taken into account when coming to this decision. No objections have been received following statutory consultation.

Special attention has been paid to the desirability of preserving or enhancing the character or appearance of the Belsize Park Conservation Area, under s.72 of the Planning (Listed Buildings and Conservation Areas) Act 1990 as amended by the Enterprise and Regulatory Reform Act [ERR] 2013.

As such, the proposal is in general accordance with policies A1, CC1, D1 and D2 of the Camden Local Plan 2017, the London Plan 2021 and the National Planning Policy Framework 2021.
