T1 - Poplar - Fell tree to ground level and grind below ground level. To complete work a separate contractor will remove the wall to expose the stump to allow access for stump grinder and final stage of felling.

All works to be carried out in accordance with BS3998 : Recommendations for tree work.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - $\circ\;$ showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
