T1: Magnolia: Approximately 6.00m: Reduce crown by up to approximately 1.20m all round, reducing overlong extraneous branches back into main crown structure. Thin crown density by 15%. General maintenance.
Front Garden:
T2: Mature Bay: Approximately 5.00m: Trim to tidy approximately 30cm reduction all round. General maintenance.
