Crown reduction removing no more than 2m in height and 2m lateral spread to shape. Not exceeding previous pruning point. Pruning all growth to bs3998. Leaving suitable growth throughout. Leaving the tree at a finished height of approximately 18m with 10m spread. Works to	

accord with good arboricultural practice and maintain the amenity vale of the tree.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
