Please identify the tree(s) and provide a full and clear specification of the works you want to carry out
T1 - camellia tree (3m) - trim with hedge cutters.
T2 - pyracantha tree (4.5m) - trim with hedge cutters, reaching as far around the crown as possible.
T3 - silver birch tree (4m) - lift crown over yew hedge by approximately 50cm and reduce crown by up to 50cm.
T4 - yew hedge (3m) - trim top and front face with hedge cutters and cut rear face almost back to main stem to widen path behind hedge. (Top level as poss, especially on right side)
You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
