Block 54-61

T1 - Portuguese Laurel tree (6m) - create 30cm clearance from wall and reduce branches in front of windows.

Block 38-43

T2 - cotoneaster & Portuguese Laurel group (6m) - create 30cm clearance from wall, lift branches to at least 2.5m from ground level and reduce branches in front of windows.

Back of 35-36

T3 - oak tree in wall (6m) - take down to ground level.

Back of 27-34

T4 - pittosporum tree (7m) - create 30cm clearance from wall and reduce branches in front of windows.

Front of 35

T5 - honeysuckle covered choisia (2m) - take down to ground level.

Calvert st

T6 - ash tree (9m) - deadwood crown and lift crown to 5m from ground level.

Front of 27-34

T7 - mixed shrubs (5m) - create 30cm clearance from wall and trim back from pathway.

Front of 26

T8 - amelanchier tree (5m) - reduce crown by up to 1m.

Middle of blocks

T9-19 - birch trees (9m) - reduce height by up to 4m.

T20 - birches and peashrub - create 30cm clearance from wall and deadwood crowns.

T21 - cotoneaster tree (5m) - create 30cm clearance from wall and lift crown to at least 2.5m from ground level over pathway.

T22 - birch trees (4m) - lift crown to at least 2.5m from ground level over pathway.

T23 - Norway maple tree (6m) - create 30cm clearance from wall.

T24 - pittosporum tree (6m) - create 30cm clearance from wall.

By nursery-

T25 - dead robinia tree (2m) - take down to ground level

Front of 77-78

T26 - ceanothus tree (2m) - take down to ground level

Manly st-

T27 - ironwood tree (3m) - reduce height to approximately 2m from ground level.

T28 - catalpa tree (8m) - lift crown away from acer to create at least 1m clearance.

T29 - dead cherry tree (4m) - take down to ground level.

T30 - dying amelanchier tree (3m) - take down to ground level.

T31 - dying laurel tree (3m) - remove deadwood from crown.

T32 - cherry tree (6m) - remove low branch growing through laurel tree.

T33 - crab apple tree (5m) - lift crown over car park to 4m from ground level and remove deadwood.

T34 - crab apple tree (6m) - lift crown over car park to 4m from ground level.

Block 8-13 Calvert St side

T35 - tree (6m) - create 30cm clearance from wall and lift crown to at least 2.5m from ground level over pathway.

T36 - pittosporum tree (7m) - create 30cm clearance from wall.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

Your plan needs to show the precise location of the tree(s) in relation to nearby property/roads/boundaries. It should, therefore:

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - $\circ\,$ marking all trees on the plan, but only numbering those to which you want to carry out work
 - $\circ~$ showing the approximate distance between the application tree(s) and buildings
 - $\circ\;$ adding other relevant features on the site (e.g. greenhouse, paths)
