"Dear Matt,
Thank you for your enquiry.  A change of use from self-contained dwelling houses (class C3) to HMO (class C4) can be done under permitted development rights, and so the owner would not have needed to apply for planning permission. Likewise, moving from C4 to C3 can be done under permitted development. If you would like confirmation, I would suggest submitting a Lawful Development Certificate. Unfortunately without an address or further supporting information it is difficult to fully establish the use of the site.
