Proposal: Alterations to shop fronts including; installation of timber framed door, tiled stall riser, awning and LED lighting, with making good of existing render and cornices, associated to advertisement consent application 2021/4299/A.

Drawing Nos: Site Location Plan 138-000, 138-100, 138-001 A, 138-200, 142-100, 142-200.

The Council has considered your application and decided to grant permission subject to the following condition(s):

Condition(s) and Reason(s):

1 The development hereby permitted must be begun not later than the end of three years from the date of this permission.

Reason: In order to comply with the provisions of Section 91 of the Town and Country Planning Act 1990 (as amended).

2 All new external work shall be carried out in materials that resemble, as closely

as possible, in colour and texture those of the existing building, unless otherwise specified in the approved application.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policy D1 of the London Borough of Camden Local Plan 2017.

The development hereby permitted shall be carried out in accordance with the following approved plans Site Location Plan 138-000, 138-100, 138-001 A, 138-200, 142-100, 142-200.

Reason: For the avoidance of doubt and in the interest of proper planning.

Informative(s):

1 Reasons for granting permission:

The proposed alterations to the ground floor shop frontages are considered to be acceptable in terms of scale, design and materials. The works are considered to be quite minor in nature which shall be carried out alongside repairs and making good, with the overall scheme considered an improvement on the exiting arrangements.

To No. 138 the works amount to repair and replacement which does not require consent, nevertheless improvements shown on the drawings are noted and welcomed.

To No. 140 the works include installation of; a glazed timber door.

To No. 142 the works include installation of; decorative tiling to the existing stall riser, a traditional recessed awning with timber front profile and sliding metal arms.

Proposed works to all three premises are associated to a separate advertisement consent application considered under reference: 2021/4299/A.

Given the minor nature of the works proposed, it is not considered to impact the amenity of any adjoining residential occupiers in terms of outlook, daylight, noise or privacy.

No objections were received prior to the determination of the application, and the site's planning history was taken into account when coming to this decision.

As such, the proposed development is in general accordance with policies A1, D1, and D3 of the London Borough of Camden Local Plan 2017. The proposal also accords with the London Plan 2021 and the National Planning Policy Framework 2021.

Your proposals may be subject to control under the Building Regulations and/or the London Buildings Acts that cover aspects including fire and emergency escape, access and facilities for people with disabilities and sound insulation between dwellings.
